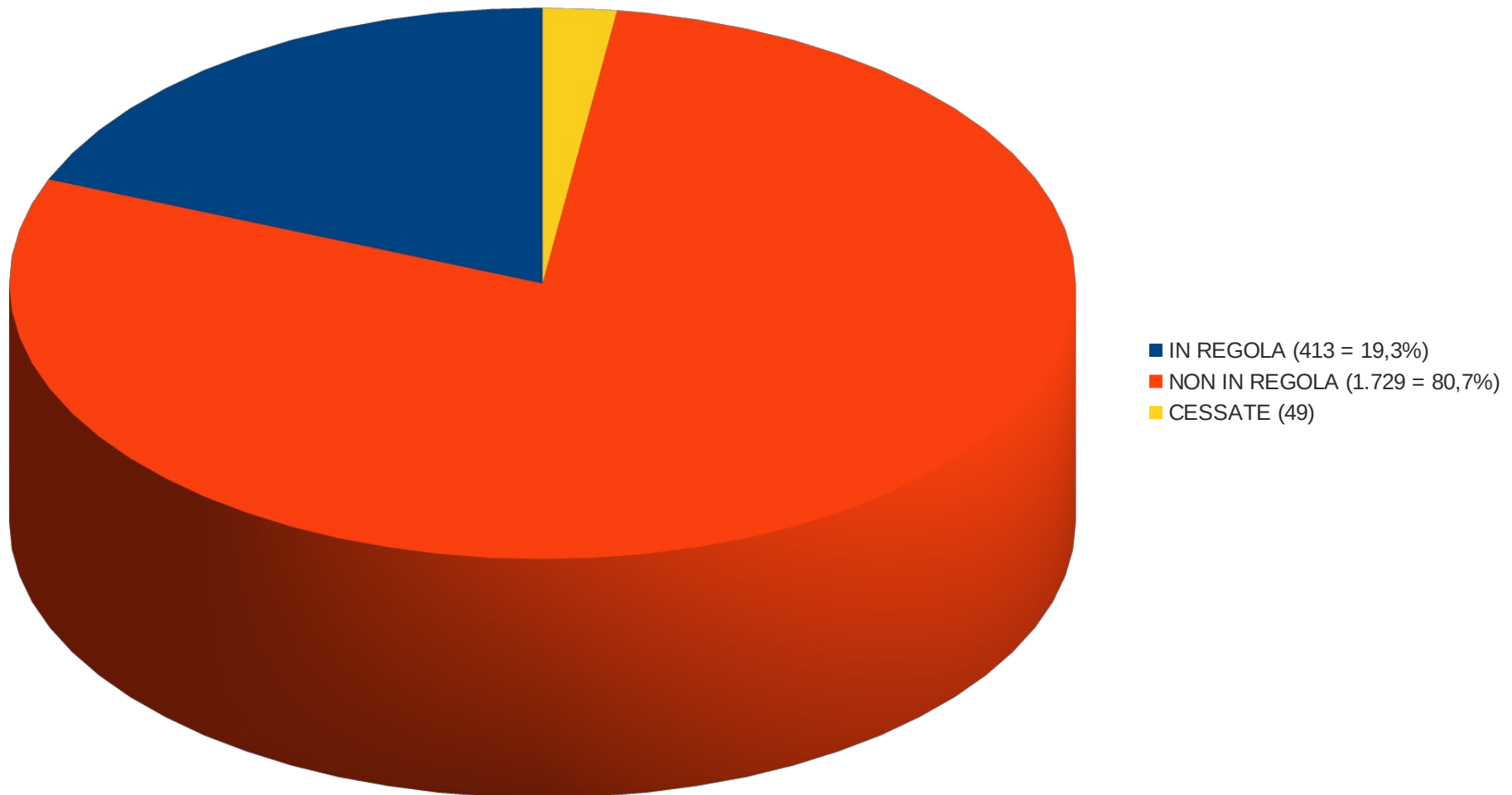

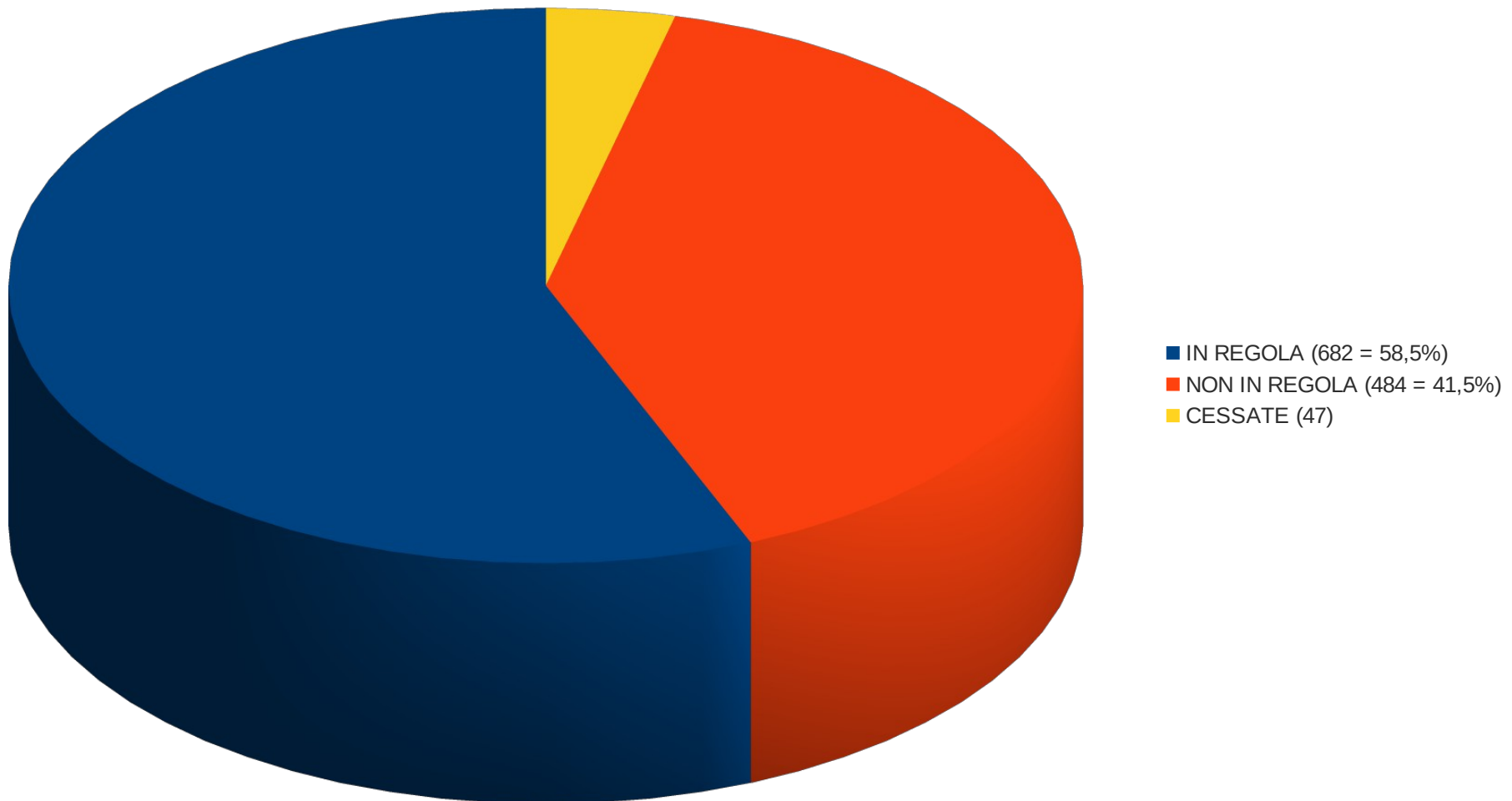

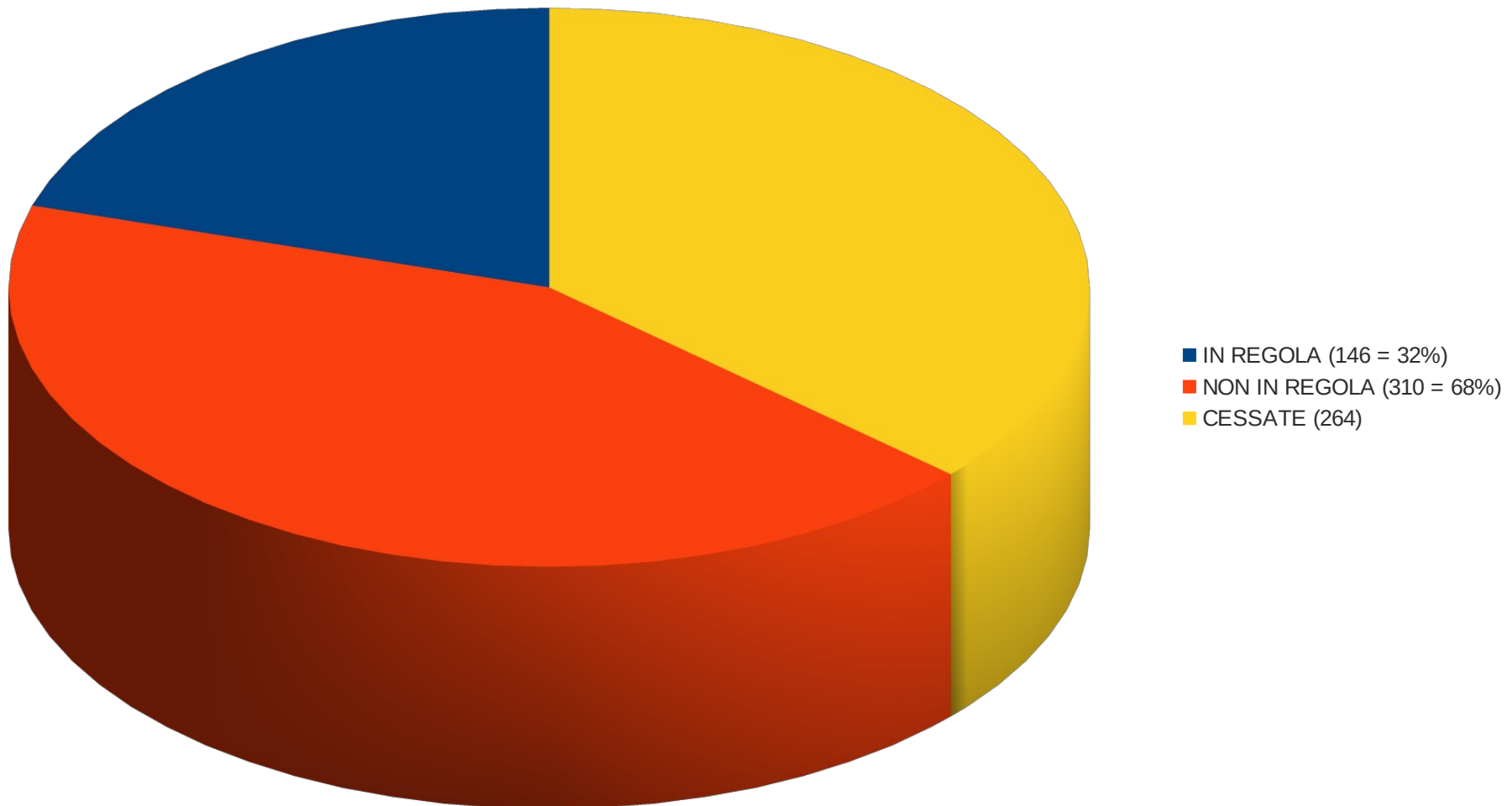

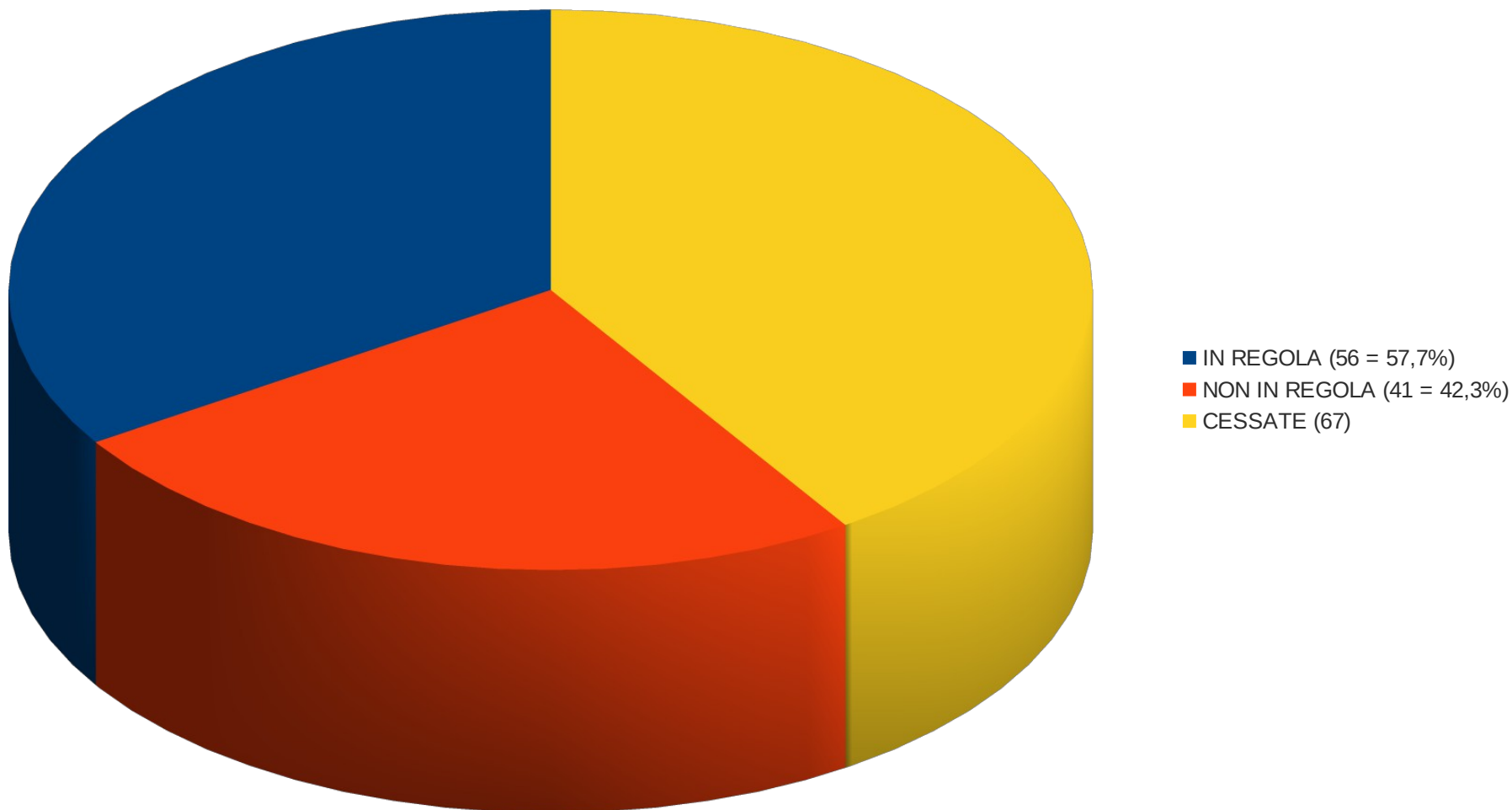

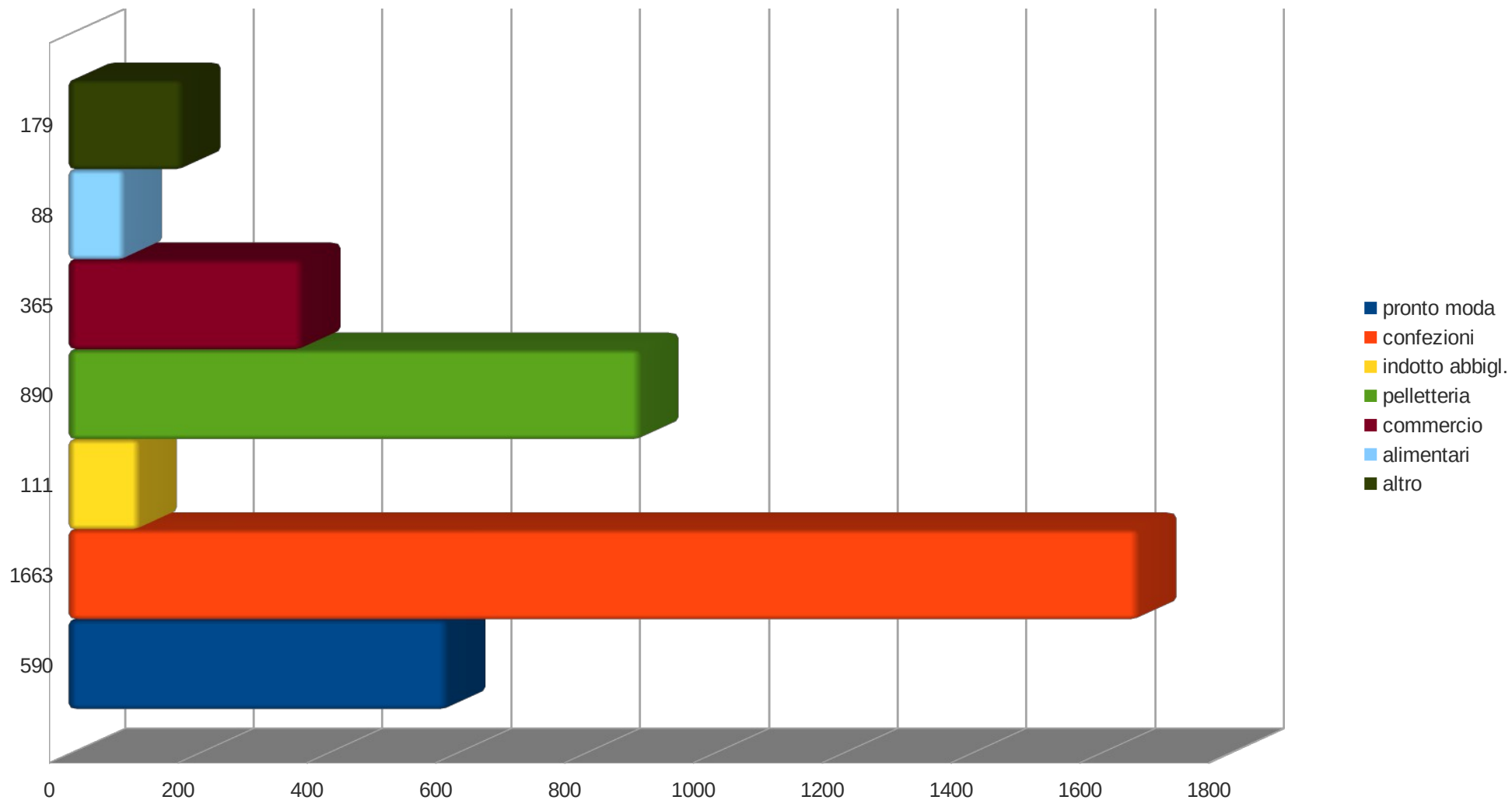

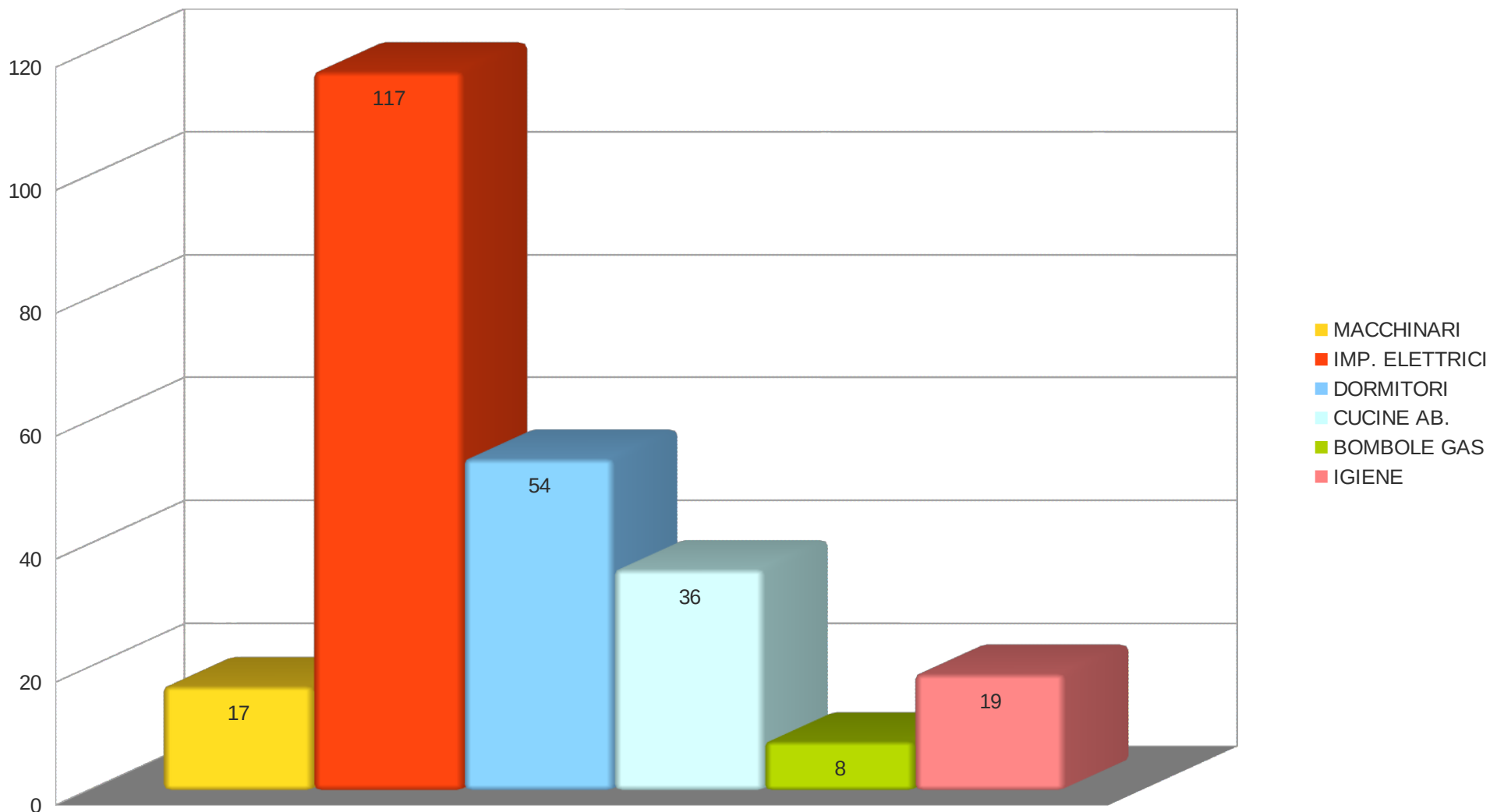

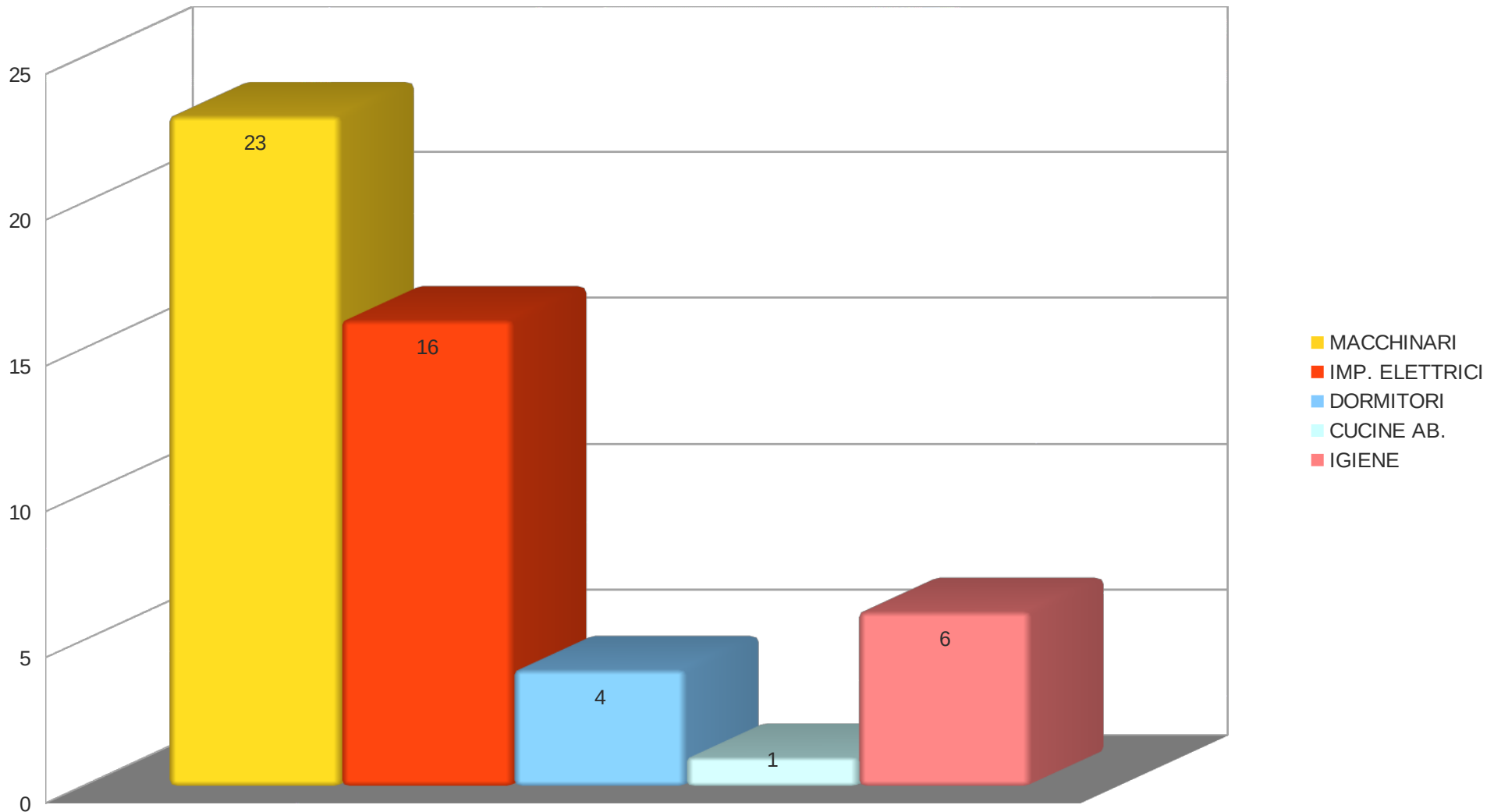

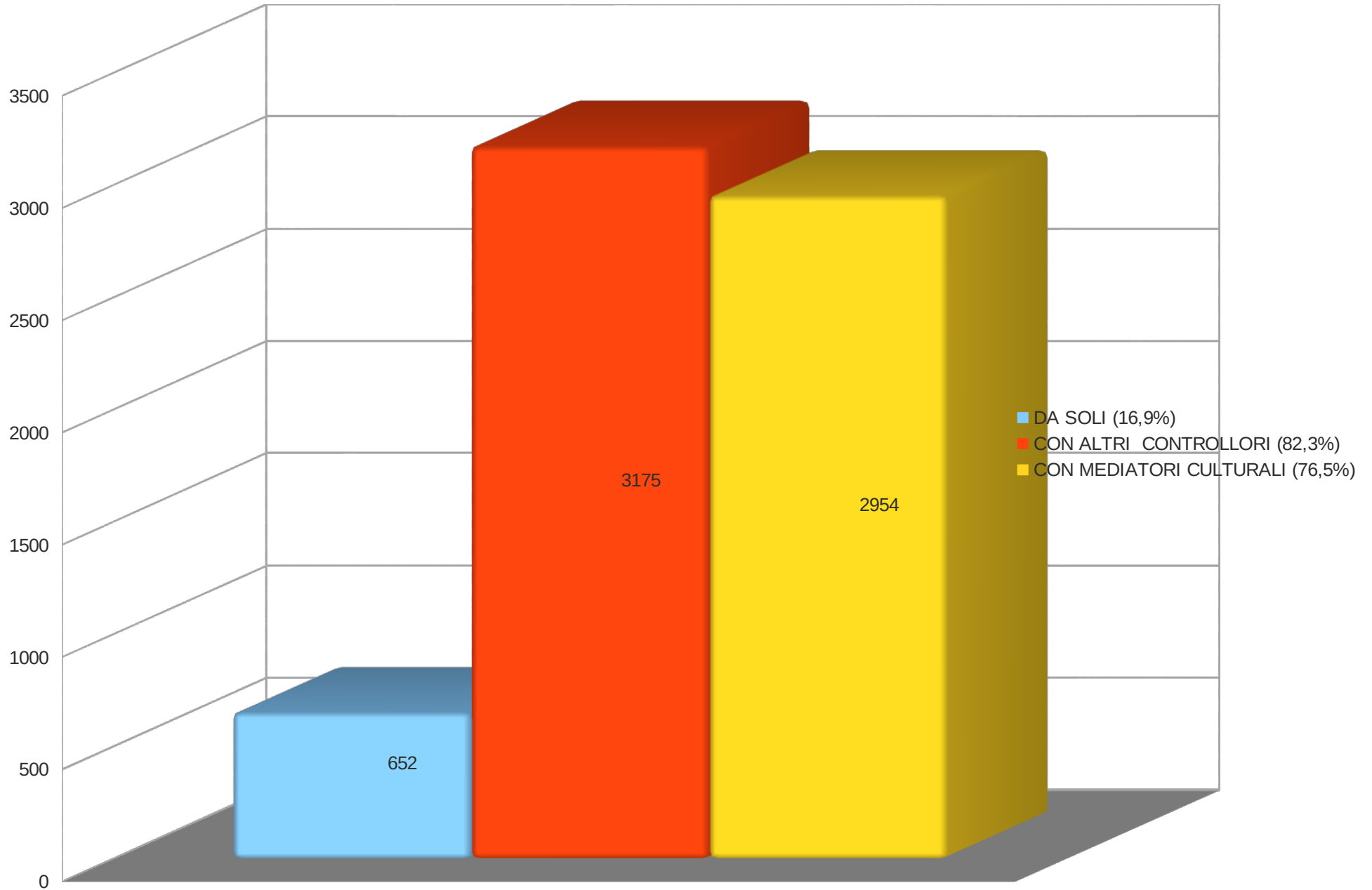

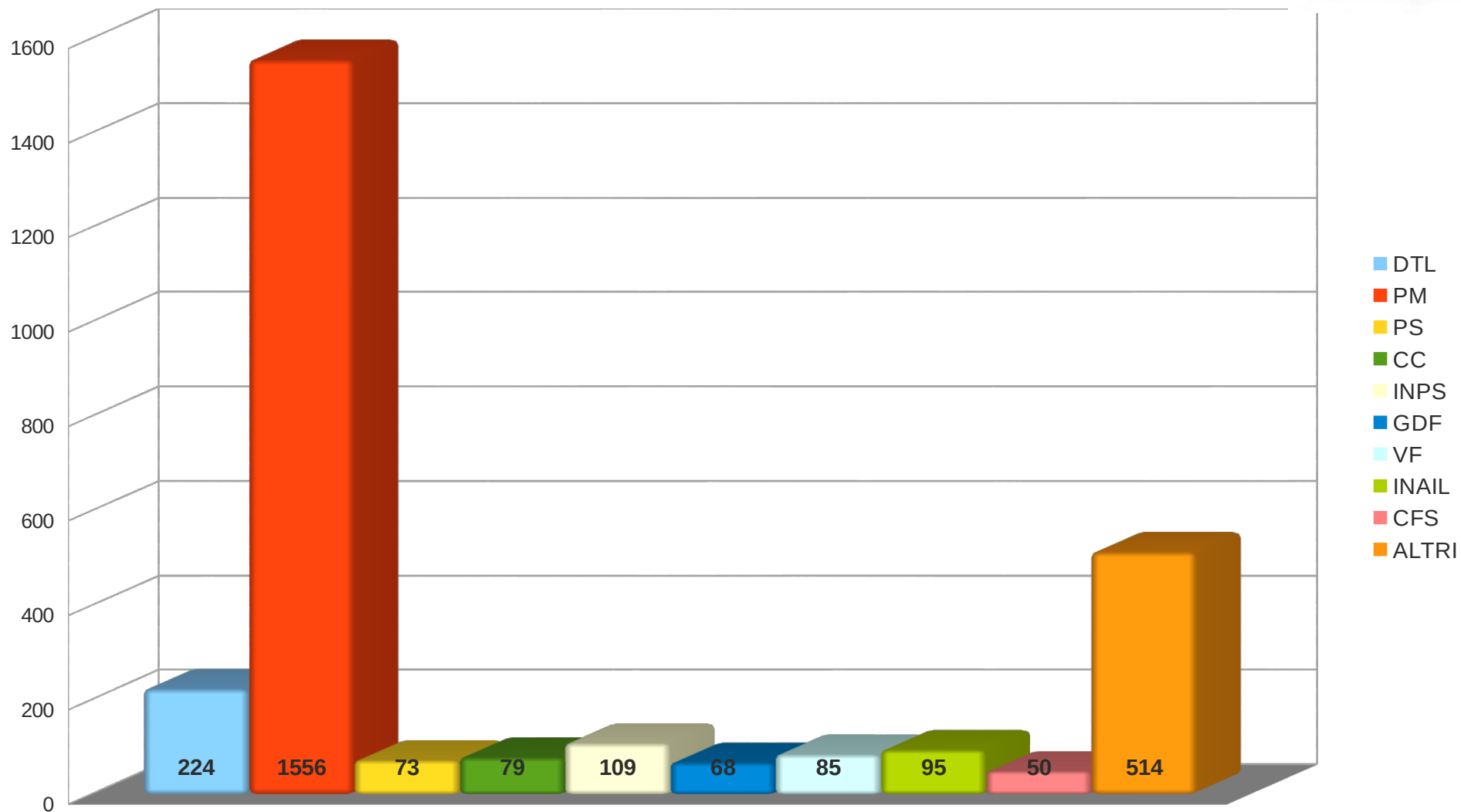

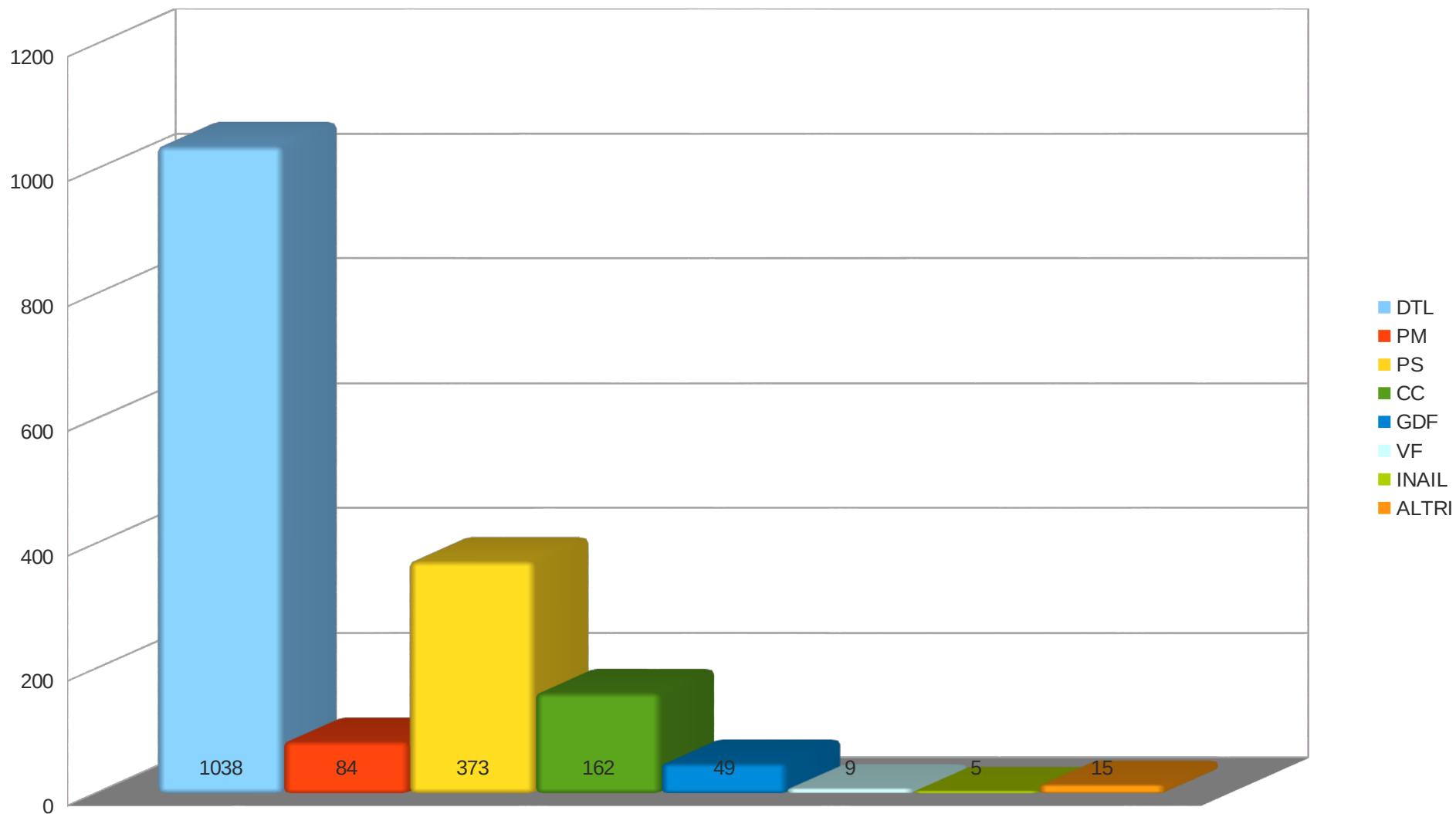

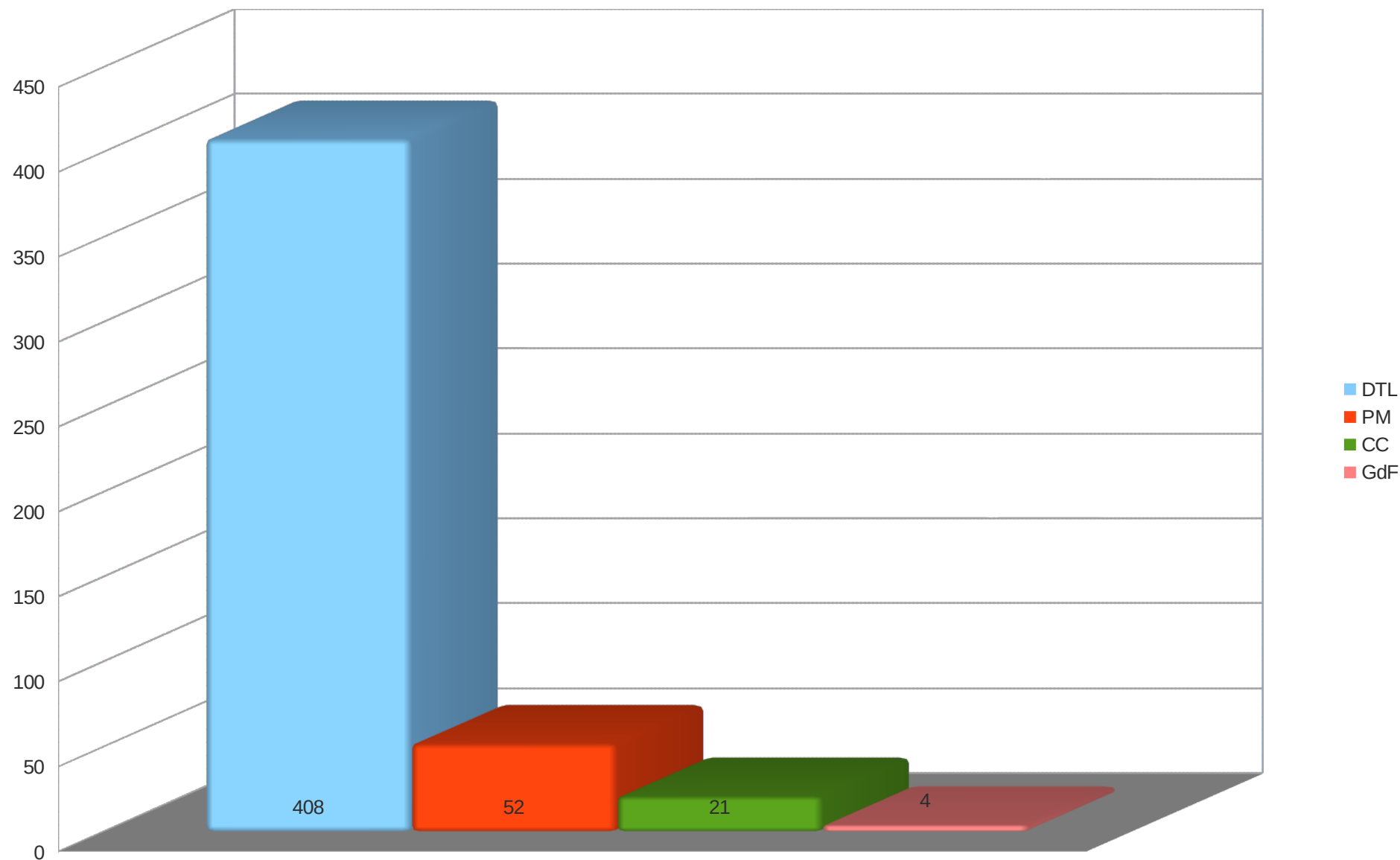

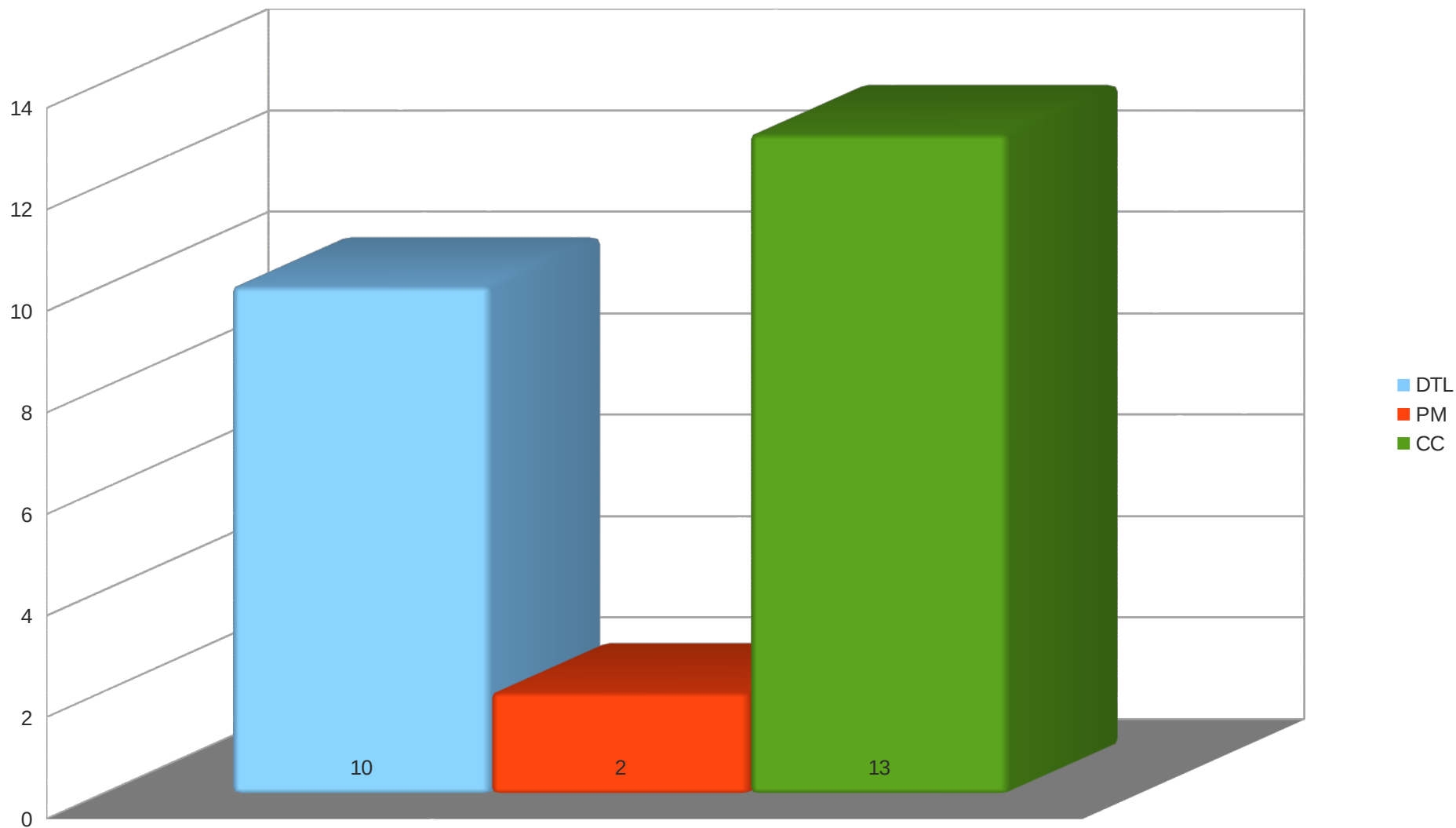

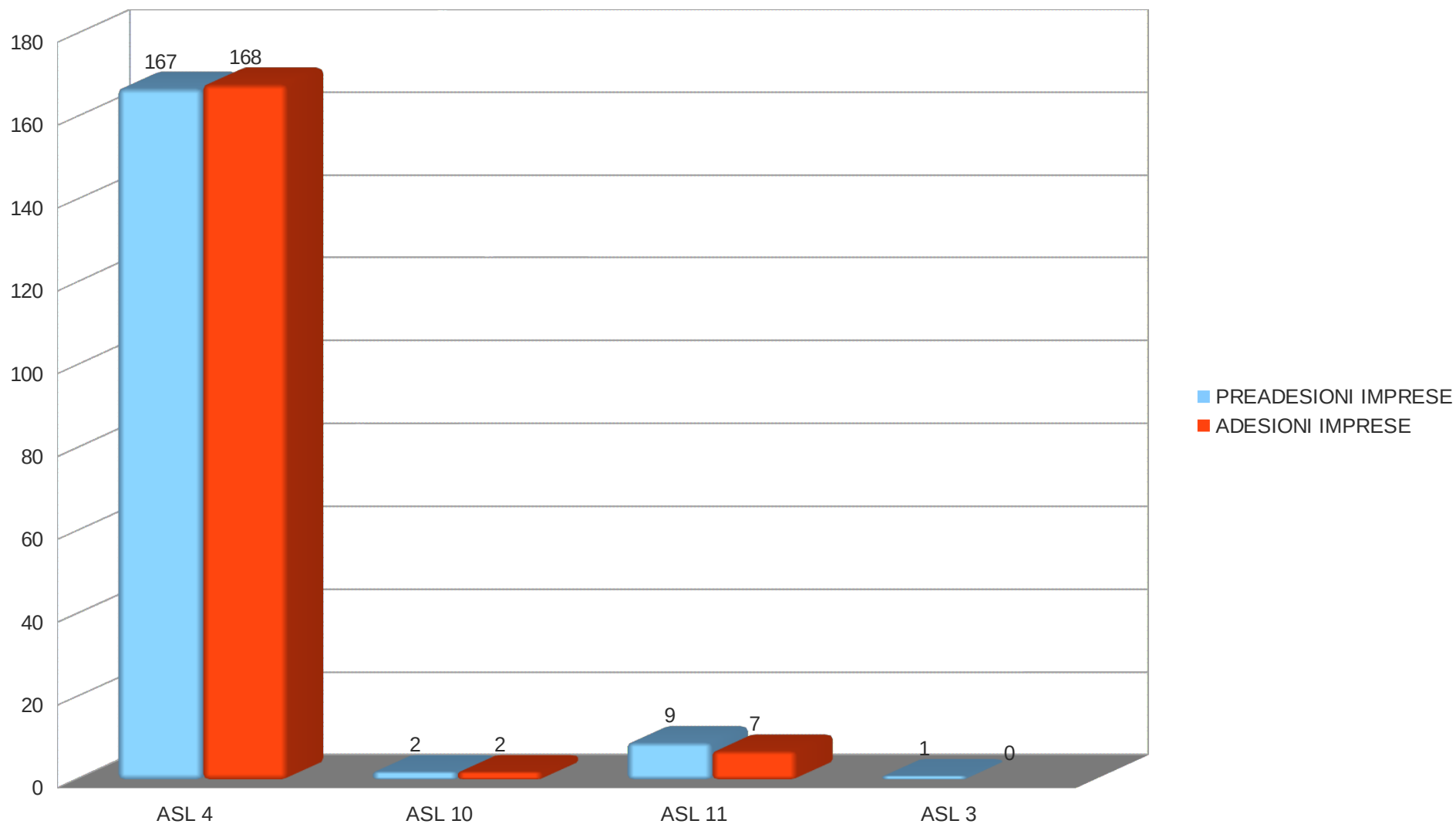

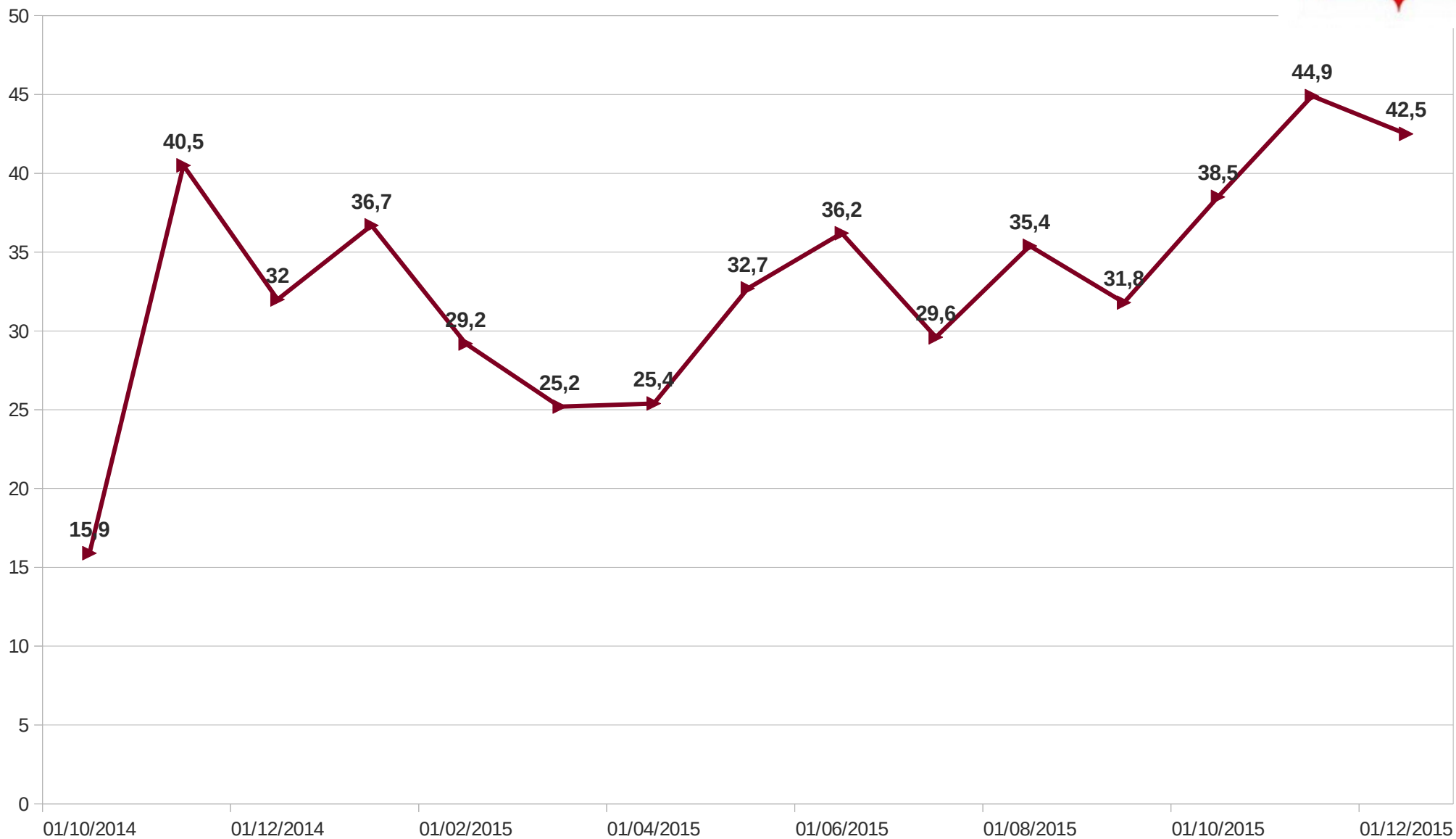

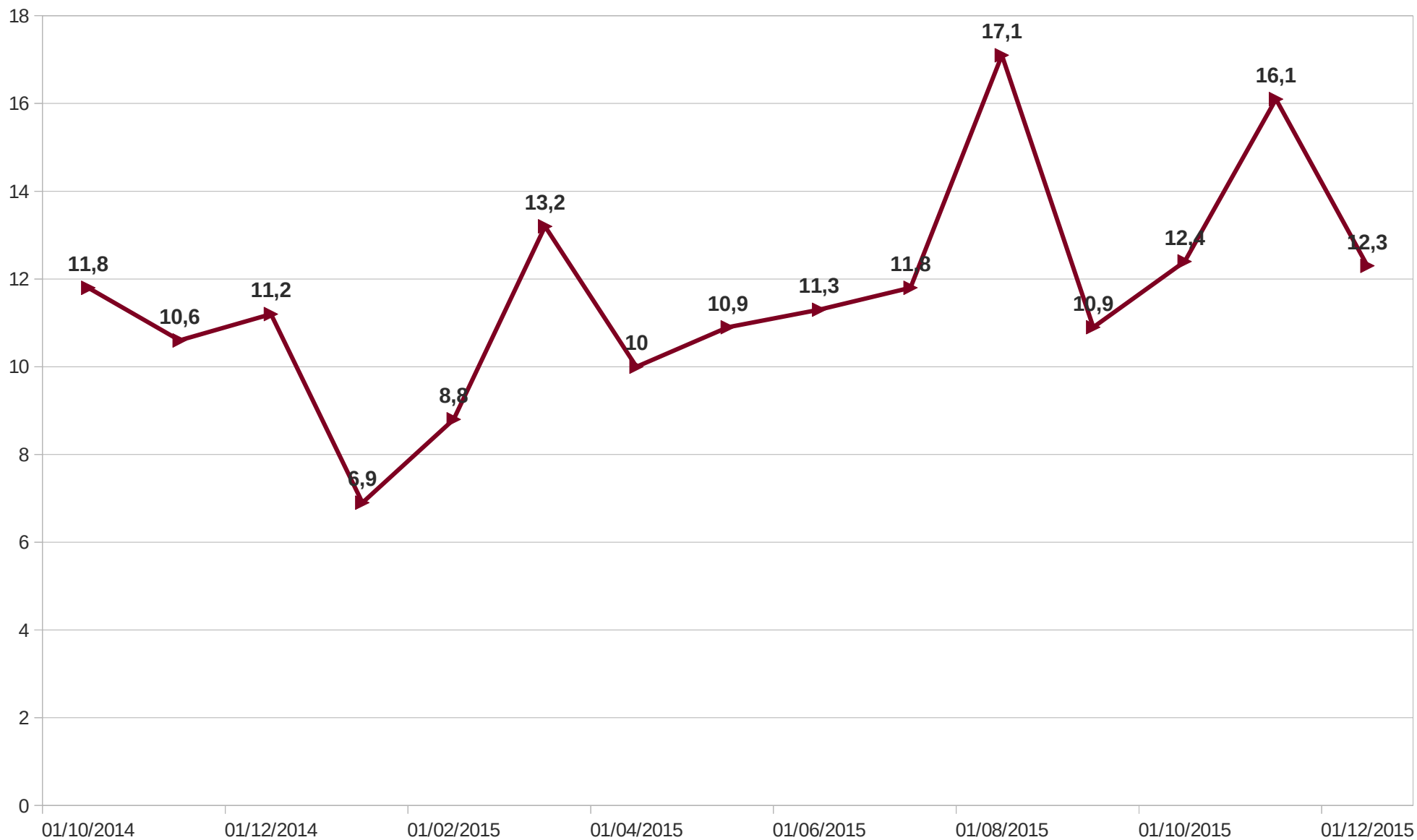

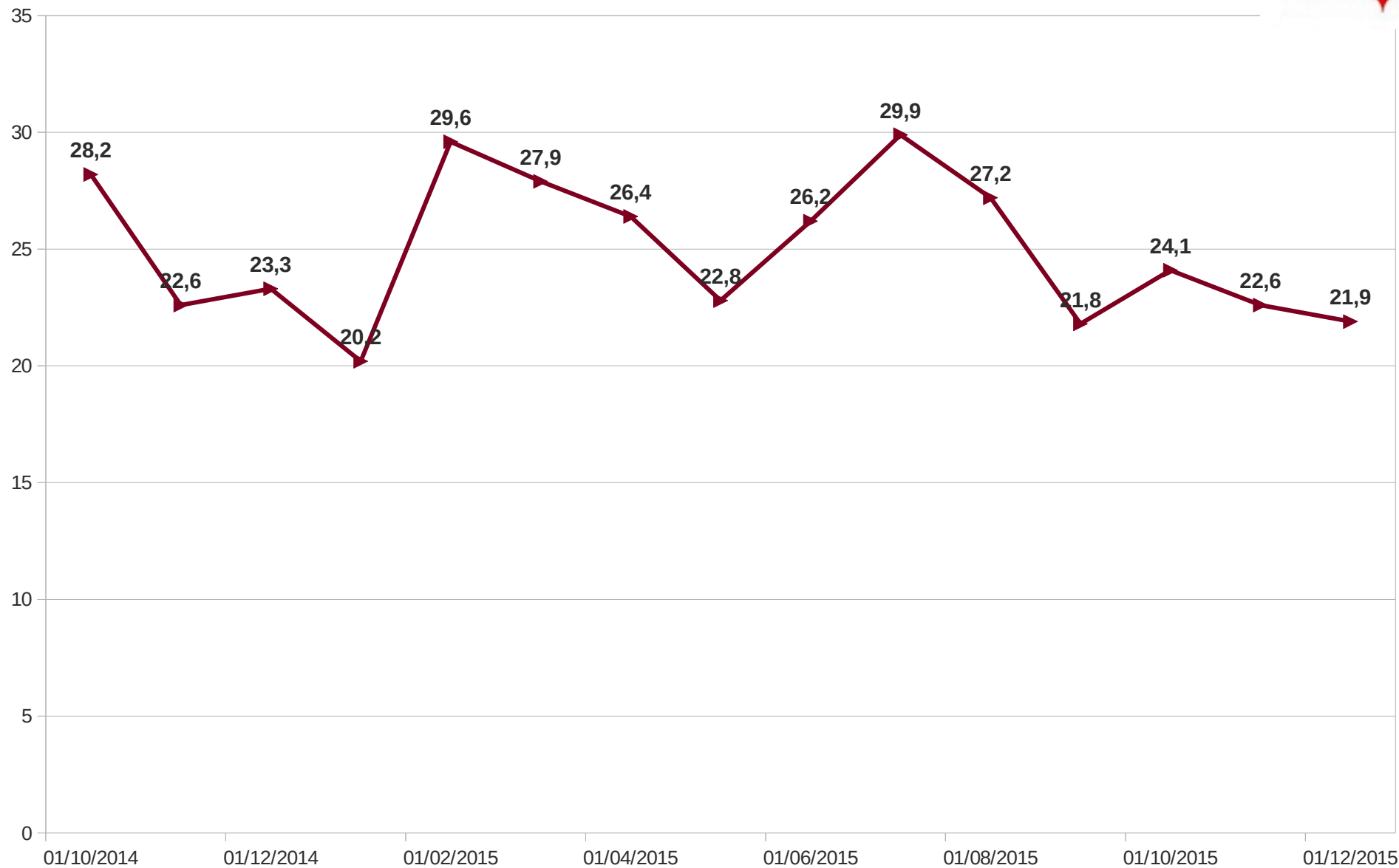
AVC – TREND IMPRESE IN REGOLA (% MESE)



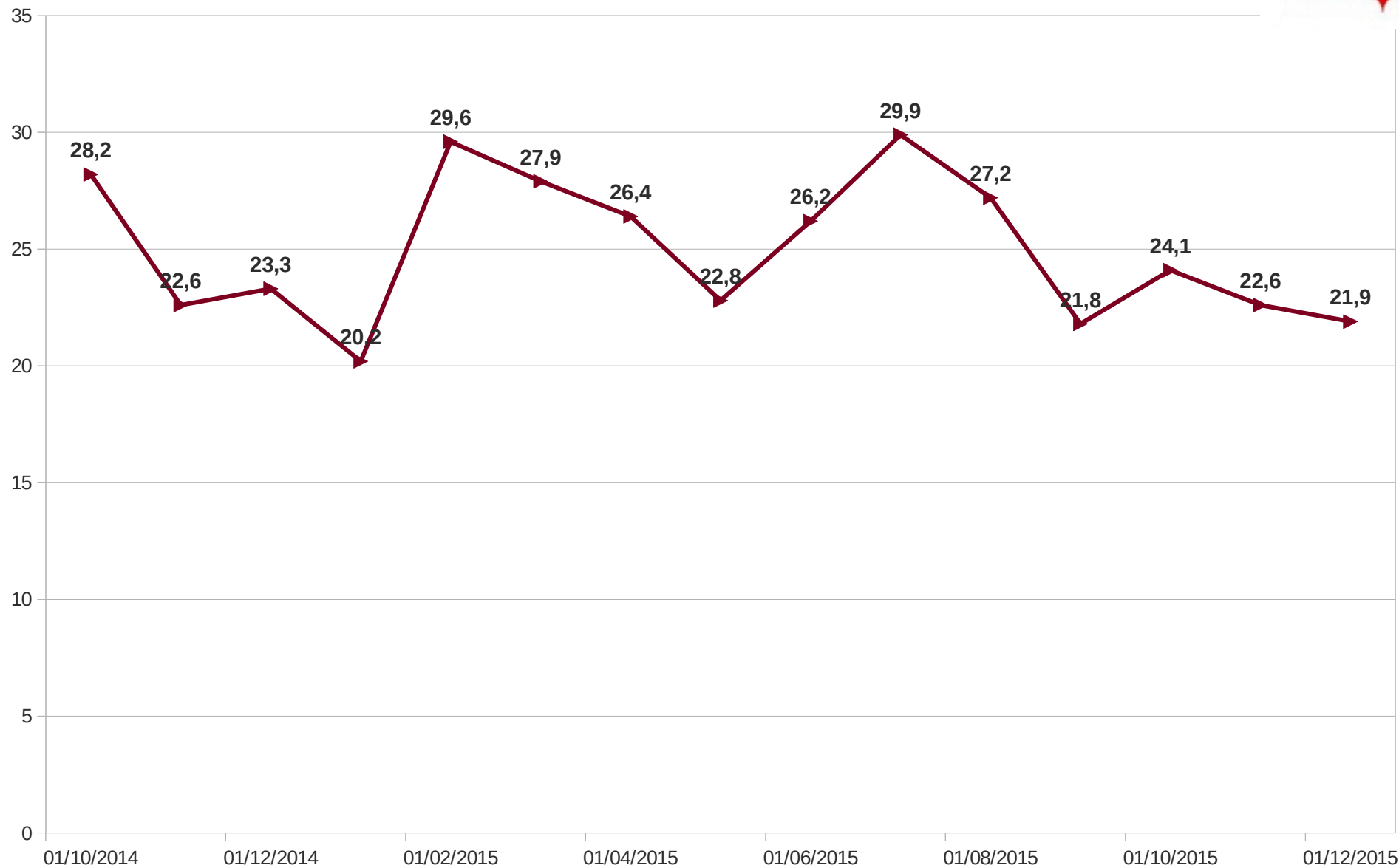
AVC – TREND DORMITORI ABUSIVI (%/MESE)

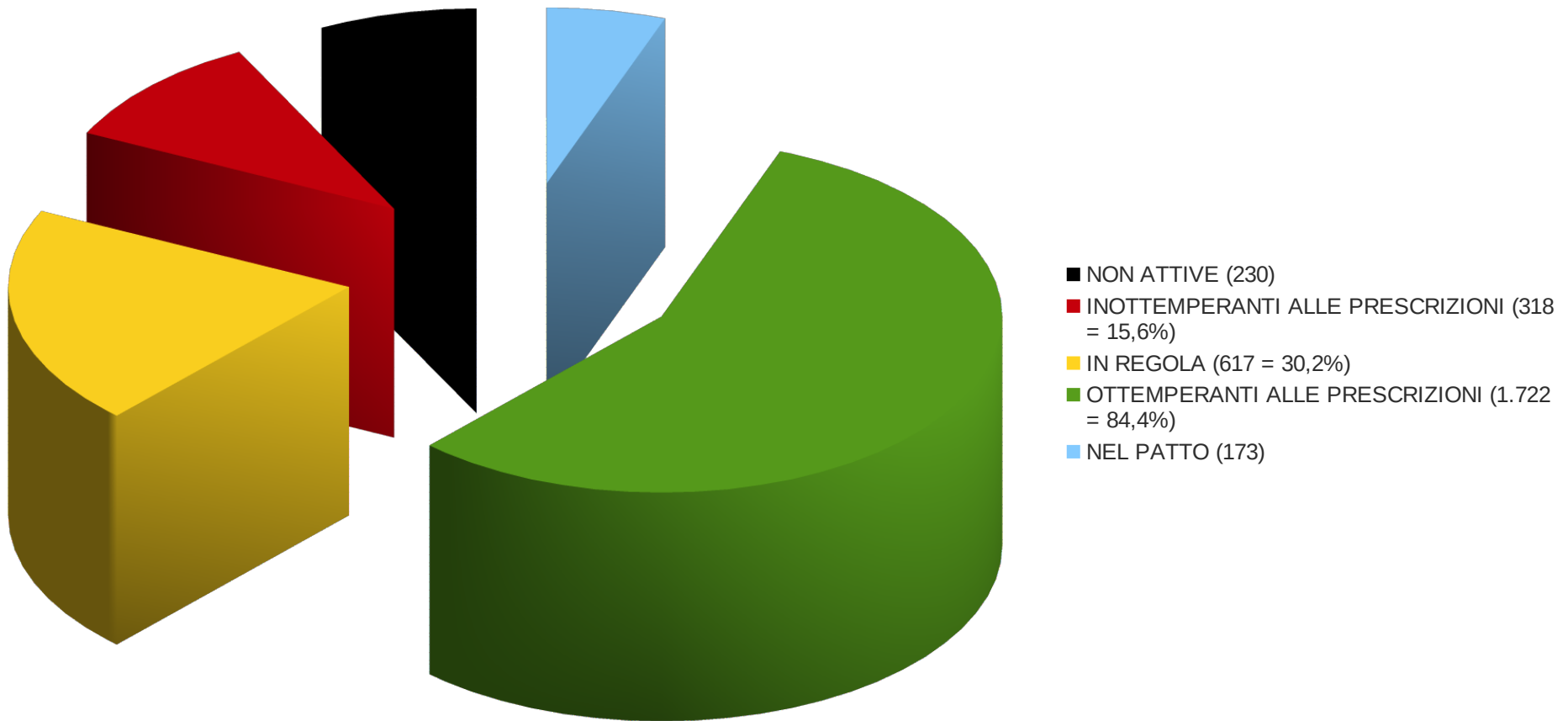

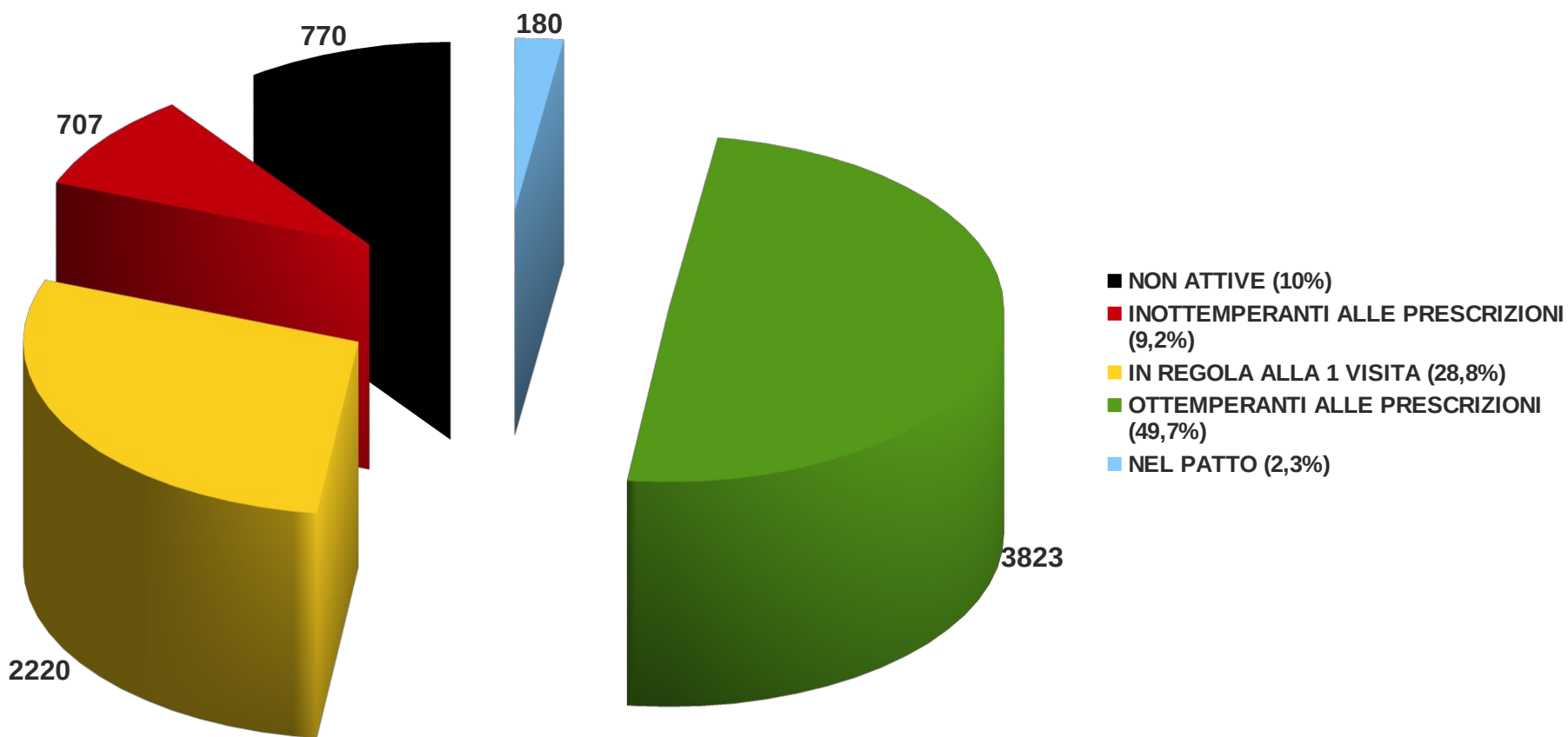
